## RESIDENTIAL OUTDOOR BURN PERMIT

This permit is valid for two (2) years from the date issued.

**IMPORTANT: Before burning, call 776-7007 to verify it is a burn day.**

### PERMIT REQUIREMENTS

1. **No burning at all is allowed inside the Air Quality Maintenance Area (AQMA) between November 1 and February 28.** Call 774-8207 to find out if you are in or out of the AQMA.
2. No burning will be allowed on days the ventilation index is less than 400. Call 776-7007 for this information. For other information, call Fire District 5 at 535-4222.
3. Burn piles must be no **greater in diameter than 4 feet, and not over 3 feet in height.**
4. Open Burn: The distance to the nearest structure or combustible material shall be greater than 25 feet. Barrel: Ground must be cleared and maintained at least 10 feet in every direction around barrel.
5. Burning of any wet garbage, plastic, wire insulation, automobile parts, asphalt, petroleum product, petroleum-treated material, rubber product, animal remains, or animal or vegetable matter resulting from the handling, preparation, cooking or service of food, or any other material which normally emits dense smoke or noxious odors is prohibited.
6. This permit is not valid for burning of demolition debris, any materials generated by a commercial enterprise, land-clearing material, construction sites or slash.
7. Burning is allowed during daylight hours only. The permit holder shall insure that the fire is completely burned out or extinguished prior to dark.
8. Open fires must be extinguished if conditions develop which would cause fire spread, i.e. wind, embers.
9. Burning must be conducted under the **constant supervision** of a person capable of taking corrective action. This permit must be available at burn site.
10. THIS PERMIT DOES NOT RELIEVE THE PERMIT HOLDER FROM CRIMINAL OR CIVIL LIABILITY FOR DAMAGES ARISING FROM BURNING OCCURRING UNDER HIS OR HER CONTROL. VIOLATIONS OF THE BURNING REQUIREMENTS MAY RESULT IN THE ISSUANCE OF A CITATION OR CIVIL PENALTY, AND/OR SUPPRESSION COSTS.

**This permit is valid for two (2) years from the above date.**
